DISPOSAL PROCEDURES

**GENERAL TRASH (MSW): GARBAGE, CARPET, FURNITURE, ETC.
DEPOSITED AT DOOR # 1; NO METAL.**

**MIXED RECYCLABLES: ALUMINUM/STEEL CANS, #1 - #7 PLASTIC
CONTAINERS, MIXED PAPER, CARDBOARD,
GLASS DEPOSITED AT DOOR # 3; SEPARATE
LIDS AND CAPS; NO HARD COVER BOOKS;
CLEAN CONTAINERS; NO LOOSE METAL;
COLLAPSE CARDBOARD; NO STYROFOAM
PEANUTS; NO PLASTIC WRAP; NO TARPS; NO
TOYS; NO LAWN FURNITURE.**

**SCRAP METAL: ALL METAL MATERIALS DEPOSITED IN APPROPRIATE
BINS LOCATED AT SOUTH END OF STATION; NO FLUIDS.**

**VEHICLE BATTERIES: DEPOSITED IN BATTERY STORAGE CONTAINER
LOCATED AT SOUTH END OF STATION.**

**REFRIGERATED APPLIANCES: DEPOSITED IN DESIGNATED BIN
LOCATED AT SOUTH END OF STATION.**

**PROPANE TANKS: DEPOSITED IN DESIGNATED AREA LOCATED
AT SOUTH END OF STATION; EMPTY TANKS ONLY.**

ELECTRONICS: DEPOSITED AT DOOR # 2; NO TELEVISIONS/MONITORS.

CLOTHING: DEPOSITED AT DOOR # 2; CLEAN AND BAGGED.

**TIRES: DEPOSITED IN DESIGNATED BIN LOCATED AT
SOUTH END OF STATION; NO RIMS.**

**MOTOR OIL/FILTERS: DEPOSITED AT DOOR # 2; NO OTHER OILS OR
FLUIDS.**

PROHIBITED WASTE

- **LIQUID WASTE: RESTRICTED TO MOTOR OIL RECYCLING ONLY**
- **HAZARDOUS WASTE: USEPA, RCCA SUBTITLE C REGULATION**
- **EXPLOSIVES/AMMUNITION/FIREWORKS**
- **ASBESTOS**
- **INFECTIOUS WASTE/MEDICAL WASTE**
- **RADIOACTIVE WASTE**
- **YARD WASTE**
- **VISUAL DISPLAY UNITS: MONITORS, TELEVISIONS, LAPTOPS**

NOTE: HOME-USE HYPODERMIC NEEDLES ARE ACCEPTED AND MUST BE SECURED IN AN EMPTY SODA CONTAINER OR SHARPS CONTAINER. CONTAINER MUST BE GIVEN TO A STATION STAFF MEMBER FOR DISPOSAL.

NOTE: PLEASE ASK TRANSFER STATION STAFF REGARDING ALTERNATIVE DISPOSAL SITES FOR PROHIBITED WASTE.

NOTE: CHRISTMAS TREES WILL BE ACCEPTED DURING A DESIGNATED SEASONAL TIMEFRAME AND DEPOSITED IN THE CONSTRUCTION/DEMO TRAILER.

OTHER PROGRAMS

CONSTRUCTION/DEMOLITION WASTE: WINDHAM RESIDENTS CAN DEPOSIT C&D WASTE IN A DESIGNATED TRAILER. RESIDENTS ARE URGED TO FOLLOW SIGN POSTING AT DISPOSAL LOCATION OR CONTACT A STATION STAFF MEMBER FOR DISPOSAL PROCEDURE.

RESIDENTIAL YARD WASTE: YARD WASTE IS LIMITED TO GRASS CLIPPINGS, LEAVES, AND PINE NEEDLES. BRUSH MAY BE ACCEPTED AT SPECIFIC TIMES. YARD WASTE IS DEPOSITED AT THE MARBLEHEAD ROAD LANDFILL SITE. PROGRAM IS CONDUCTED EVERY 2ND AND 4TH SATURDAYS OF EACH MONTH (APRIL THROUGH NOVEMBER) FROM 11 AM – 3 PM . A TOWN EMPLOYEE WILL SUPERVISE ACTIVITIES AT SITE. DECOMPOSED MATERIAL WILL BE AVAILABLE FOR PUBLIC USE. PUBLIC MUST OFF-LOAD AND LOAD THE MATERIAL. **CALL HIGHWAY AGENT AT 765-5367 FOR ADDITIONAL INFORMATION.**

HOUSEHOLD HAZARDOUS WASTE COLLECTION: HOUSEHOLD HAZARDOUS WASTE IS MATERIALS THAT ARE PROHIBITED FROM CONVENTIONAL DISPOSAL DUE TO THEIR HAZARDOUS PROPERTIES PER USEPA REGULATION. THE COLLECTION OF THESE MATERIALS IS COORDINATED THROUGH THE NASHUA REGIONAL PLANNING COMMISSION AT (603) 883-0366 OR WWW.NASHUARPC.ORG. COLLECTION EVENTS ARE SCHEDULED THROUGH THE COMMISSION THEN POSTED AT STATION AND WEBSITE. PLEASE CONTACT STATION FOR INFORMATION.

MERCURY PRODUCTS: FLOURESCENT LIGHTS, THERMOSTATS, AND OTHER MERCURY PRODUCTS ARE ACCEPTED AT STATION. **PRODUCTS MUST BE GIVEN TO A STATION STAFF MEMBER FOR PROCESSING.**
